- I. Inventory Management System software manages stock tracking and transfers, management of purchase and sales orders.
- II.HMS software Manorama Lifeline. The University had a Hospital management system installed in the year 2009, which was later upgraded in the year 2015 with all modules like Reception, Nursing station, OPD billing, Radiology information system, Laboratory information system, Cath lab, Operation theatre, BME, Dietician, Pharmacy, IPD Billing, Discharge summery, MIS. The University has installed Manorama HMS software solution named 'Lifeline suite' and Dell Power edge R540 Server with License Microsoft Windows server 2019 and MS.SQL Server 2014 with all user Cal. Manorama software is developed using ASP.Net plus C#, Model View Controller (MVC) framework that is invariably deployed on Internet Information Server (IIS). For storage there is Microsoft SQL server. Daily backup utility is scheduled on HMS Server Nash box and monitored, along with monthly backup and preventive maintenance of server and network. Quick heal Server edition antivirus is used for security of data and operating system. University has installed Sonic wall NSA4600 firewall for security.
- III. SAAKI Students Academic Administration of Krishna Institute (SAAKI) is a software program designed for academic administration of students. All students, parents, alumni and teachers are registered on this platform. Its primary function is maintenance of student's records like attendance, performance, timetable, notices and circulars. It also serves as supportive aid for teaching learning in the form of assignments, conduct of tests and modular teaching. It is a fastest mean of correspondence between teachers, students, parents, alumni and the administrative wing. It contains interesting features like enotice board, SMS service, email service, space to maintain learning resources.
- IV. HR Management System: HRM System organizes and manages all the employee database from single point. From HRM system end user

can track the leave record, attendance and time record. HR
Management System provides various reports, from recruitment
to retirement. Reports are available in various formats like Excel
and PDF.

- V. Accounting and Finance management Software: For Accounting and Financial management Tally software is used.
- VI. Exam Management system: In this software student registration, hall ticket issue, result processing is done.

VII. Library Management software: Library has facilities such as Library Management Software (Koha) and Online Public Assess Catalogue All books are barcoded. LMS is a totally integrated software package encompassing all aspects of library management. This software covers all areas within the preview of the LMS for efficient Information Management and at the same time provides a precious tool for all its members to have access to these resources at their fingertips. Library has elearning resources like edatabase, eJournals Package, KHub and Medical elibrary database. MUHS Digital Library contains scholarly journals, videos and audio, dissertations and theses, magazines, books, newspapers, trade journals, reports etc. This can be accessed on Wi-Fi the campus with IP address. Web OPAC is a computer based and supported library catalogue designed to be accessed via terminals so that library users may directly and effectively search for and retrieve bibliographic records without the assistance of a human intermediary.

15. Multidisciplinary / interdisciplinary

Taking an initiative towards actualisation of NEP - 2020, the Krishna institute of Medical Sciences Deemed to be University has recently rechristened as Krishna Vishwa Vidyapeeth, (Deemed to be university) Karad. The University has revised the perspective development plan (PDP) which will give a truly multidisciplinary perspective with congruent revision in the vision, mission, and objectives. To actualize the NEP 2020 and the goals thereon, the university is paving its way forward in integration of humanities and science in medical sciences programmes. At present University has 38 CBCS programmes having electives so as to make them flexible. The University has started New Post graduate and UG Programme in Environmental sciences with the vision to provide degree, degree with honours of integrating the masters and PG programmes. Presently we have lateral entry provision in B Pharm program and we have plan to implement this in other programmes. Our multiple MOU's with industry and non-health sciences institutions will promote

multidisciplinary research endeavours.

16.Academic bank of credits (ABC):

KIMSDU has been registered under ABC. In the University we are working on to permit learner to avail the benefit of multiple entries and exists during the programmes. The University through the academic council has also adopted the Credit Framework for Online Learning Courses through SWAYAM Regulations, 2021. NSS as elective also adopted in CBCS program curricula.

To design our own curricular within the approved framework, an expert committee was appointed by the university. The said committee proposed same joint degree programmes and good practices pertaining to the implementation of ABC. New mark sheets have been designed as per format of ABC.

NEP-2020 calls for promoting India as global study destination and convergent with same KIMSDU has more than 11 international MOU's as per the UGC guidelines for Internationalisation of Higher education. KIMSDU & Merk Foundation, Africa have collaboration in the field of specialised training for doctors in oncology. The program is called 'KIMS-Merck Foundation Africa Oncology Fellowship Program'. Student from Malawi, Sierra Leone have completed one year fellowship in Fellowship Surgical Oncology & Fellowship in Pain and Palliative Medicine respectively. Students from Niger are perusing Fellowship in breast Oncology & Fellowship in Urologic Oncology as well Nursing oncology fellowship for nursing students is also been worked out.

17.Skill development:

Competency Based Medical Education is been adopted to Medical Sciences as well Competency Based Nursing Education is adopted to Nursing Sciences by University. Training in Attitude, Ethics and Communication skills (AETCOM) is an integral component of clinical skill training in all Health Sciences programs and course regarding training in 'Communication skills' is a part all non-health Sciences programs of the University. In the medical sciences the university is incorporating training of the medical students in narratives, attention, observation, historical perspective, and ethics as given in the AETCOM module.

Motivational lectures of eminent personalities through Value education cell are arranged to promote the common values like humanism, national integration, and selfless service. NSS, NCC units engages students to imbibe qualities of leadership, social service, responsible and awakened citizenship to cherish the values of

equality, social justice and tolerance. Students' wing of Bioethics of KIMSDU aims to sensitize and educate health professionals about importance of bioethics in day to day clinical practice and research.

Some of our programs have credit based compulsory industry based internship which is essentially skill based. Orthotic & prosthetic department where skill based education is provided. University is in process to start vocational courses in alignment with NSQF. So that at least one vocational course will be available to each student as per their choice.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The university is starting a new faculty of Ayurveda that will combine all the faculties for their basic sensitisation regarding the Indian System of medicine.

University has adopted five villages providing health services so as to teach them Indian social system including local language and culture. Students are promoted to talk and discuss with the patient, relatives & rural people in local language and answer their queries thus promoting bilingual mode.

KIMSDU is proactive in practicing gender equity in all its activities. The university encourages students to celebrate their own religious, regional festivals within the campus where students of other faith and region participate actively to build a sense of Unity and sociability. Festivals of different faiths like Christmas, Eid, Onam, Diwali, etc. are celebrated to enable harmonious coexistence among all stakeholders. The birth days of freedom fighters is celebrated as National Unity Day to encourage and reinforce unity, integrity and security of nation. Marathi learning classes are being conducted for Students being a vernacular language.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

KIMSDU has implemented Competency Based Medical education in medicine and Competency based Nursing Education for Nursing. KIMSDU ensures identification of Graduate Attributes and escalated POs, PSOs and COs on the basis of guiding principles at each level. The strategic Initiatives are aligned towards attainment of the desired outcomes (PO-PSO-CO) in terms of qualitative and quantitative parameters. The University has aligned all Instructional and assessment strategies towards attainment of outcomes in every

curricula.

KIMSDU has given the emphasis on changing the educational instructional strategy from "teaching to learning; skills to thinking; content to process; and teacher instruction to student demonstration in each program under University that will stimulate and motivates a student centred teaching-learning method and ensures better accountability and assert quality. It has been ensured to master the necessary "soft skills such as ethics, responsibility, life-long learning, and knowledge on the current issues. By having OBE in our university which is responsible for troop significantly higher grade point average in their academic performance as well raises spirits of contribution and partnership with manifold disciplines and interest groups in preparation and executing the curriculum.

20.Distance education/online education:

The recent pandemics necessitates that we are ready with alternative modes of teaching and KIMSDU had fully utilized its own model of learning management system (SAAKI) for all the teaching learning and related activities across all the academic programs. Teachers require suitable training and development to be effective online educators. In this regard we trained them for e- content delivery and content creation. KIMSDU has trained the teacher for e-content development online mode as well offline mode. Teachers and students are appropriately utilizing existing e-learning platforms such as SWAYAM. University has substantially provided digital infrastructure. E- PG pattshala LMS from inflibnet has been working on University website. The lecture capturing system (impartus) has been functioning in 6 lecture theatres. Recorded lectures and Power Point are available for students. The University has taken initiative to start Distance Education / Online Learning programmes. In said regard we are starting separate Directorate. Fun based learning student-appropriate tools like apps, gamification of Indian art and culture, in multiple languages, with clear operating instructions, will also be created.

In this connection Research Grants writing and Industry-Academia Collaborations, workshops& seminarsare regularly beingorganized.

The proactive involvement of the university in this direction has greatly boosted the IPR related activities and research. In the research workshop the participants are guided to carry research in step by step manner and are trained to prepare research projects in their domains. KIMSDU has been granted 16 patents, 13design patents, 161copyrights.

Research proposals are approved by Ethics Committeemeeting that is convened regularly. The Laboratory is approved by the NABL and NABH. Pharmacy and Collection practices exist.

Industry-Academia collaboration is robust. IPR in healthcare is encouraged by promoting the ideation, creation, testing, and validation of research concepts by developing prototypes in collaboration with industries. There are 55+ prototypes out of which 7 are tech transferred and 2 are commercialized as of now. Industry-academia collaboration is robust and this interphase may generate traction in the post-IPR process like making MVP, testing, validation, market analysis and commercialization of the innovations.

The Eco-Friendly 57 acres campus of the University is situated in Karad. The University has state-of-art Teaching-Learning classrooms, laboratories and information centres.

ICT Enabled Classrooms & Seminar Halls: The Lecture Halls of Constituent Faculties of the University have been enabled with ICT. The teaching hospital is NABH accredited and has a classroom for live demonstrations with two-way audio-visual link to operation

theatres.

Facilities for Clinical Learning: University has 1320 bedded teaching hospital with adequate clinical material. Every clinical dept has teaching area attached to every ward. The University has Urban, Rural and attached satellite centres for community teaching. Video conferencing with John Hopkins University (USA) & three other institutes on HIV/AIDS is held on monthly basis.

Laboratories & Museums: Laboratories are equipped with state of art equipment as per the requirements of statutory councils.

Skill and SIM Lab: Laboratories have trained faculty to handle the mannequins and to train the students for various surgical, paediatric and ob/gyn procedures.

Advanced research facilities: University has a Molecular Biology & Genetics Research laboratory, Lead Referral Laboratory and Virology laboratory.

Every hostel building has their own recreation room along with TV & other facilities and indoor games apart from the central facilities. There are three separate gymnasiums, a specially equipped gym for ladies and aerobics/yoga hall, 680.74 sq.m Auditorium with a sitting capacity of 1000 seats, equipped with cutting edge audio-visual system, A dedicated yoga centre with 232 sq.m and 1400 sq.m outdoor Amphi theatre with 1000 seating capacity are located in campus.

4.1.3 - Availability and adequacy of general campus facilities and overall ambience

The tranquil and luxuriant campus has all the necessary amenities for students & staff providing a comfort zone. The campus maintains self-reliant basic facilities and security with CCTV surveillance 24x7.

The campus has 13 well equipped hostel buildings for students with all amenities. NABH accredited Krishna hospital has 1320 beds with 24x7 pharmacies. There are 3 Canteens, 1182 washrooms, 229 urinals and 1047 bathrooms including dedicated handicap friendly washrooms. The Krishna Sahakari Bank provides banking needs along with ATM. The campus has a new Central Park constructed on a green hill. Green campus audit is conducted regularly and necessary changes are made accordingly. The campus has a newly built 3 floored parking lot, walking pathway, tactile pathway and water fountains. The campus has Waste Management facility for bio-medical waste. Recycled water is used for maintaining greenery in the campus. A total of 14 rain water harvesting sites collect 1,15,00,000 litres of water per year.

Along with the native flora (3096 trees) and fauna the institute also has toxicology garden. There is 900 KW on-grid solar plant which fulfils 40% electric requirements (10,41,224 KW) in campus in addition to Central solar water heater and heat pump with a capacity of 5000lit/day.

The Multi-Speciality Hospital is recognised by National Medical Council with an undergraduate intake of 250 students per year. The hospital has modernized with state-of-art infrastructure. The hospital meets with all the regulatory requirements in terms of faculty, clinical material, equipment etc. including the newly established Emergency Medicine department.

Laboratory:

The Central Clinical Laboratory and Imaging Services with CT, MRI, X-Ray and imaging intensifier, Mammography, Sonography and Colour Doppler, ECG, EEG, EMG and BERA services are upgraded with latest breakthrough in technology.

Clinical teaching-learning facilities:

All facilities as per National Medical Council regulations are available like OPD, IPD, Museum, Library, Classrooms, Seminar halls, Modern skill lab equipped with basic and modern mannequins.

Dental Hospital: Number of dental chairs are increased to meet new requirements of Dental Council of India.

Faculty of Physiotherapy has a state of art infrastructure with separate OPD to train students.

The Faculty of Nursing Sciences, Pharmacy, and Allied Sciences are well equipped as per norms of their regulatory bodies. Quality of learning is upgraded regularly with upgradation in equipment and infrastructure.

4.2.2 - Describe the adequacy of both outpatients and inpatients in the teaching hospital vis—a–vis the number of students trained and programmes offered (based on HIMS / EMR)

Krishna Hospital has intake of 250 UG, 123 PG and 6 Superspeciality students. The Hospital has adequate number of patient flow into IPD and OPD on a daily basis. Hospital has sufficient facilities for the training requirements of undergraduate, postgraduate and super-specialty students with well-equipped lifesaving support facilities, intensive care units, burns ward, casualty and emergency medicine services.

Hospital has more than 80 % of the beds admitted with patients at any time. The average daily OPD is 2350/day. Patient numbers for both IPD and OPD patients have grown steadily. The compounded annual growth rate for OPD is at 7.68 % while for IPD is 5.8%.

The Government schemes like Maharashtra Police Kutumb Arogya Yojna, Ex-servicemen Contributory Health Scheme and Mahatma Jyotiba Phule Jan Arogya Yojana have been successfully implemented in the Hospital along with 10% beds reserved for indigent patients and 10% for weaker section.

School of Dental Sciences with UG intake of 100 students and 23 PG students provides teaching and learning requirements. The facilities provided for clinical training are beyond the DCI stipulations for

providing high quality training facilities. The average patient inflow is more than 500 patients/day as proposed by Dental Council of India.

The university provides the best of the learning resources to the students and arms its teachers with the latest knowledge through its library resources. KIMSDU has upgraded its library with all necessary infrastructures, ILMS, digital resources, ICT resources besides all necessary procedures for their effective use.

Library Management System is operated through Open Source LMS to provide the rights to study and distribute the library resources. The automatic RFID system carries out issue/return of the books and keeps record of transactions on a real-time basis. System also helps in keeping accurate circulation/inventory reports.

KOHA WEB OPAC: Koha provides a full-functioned Online Public Access Catalog (OPAC). The system software is continuously updated to remain in line with the latest technological advancements like continuous mustering of skills to work with different tools and techniques, so that the benefits of the technology reach the end users.

After implementation of RFID from August 2021, issue and returns of books, Journals are easier, smooth and faster with digital records of these transactions.

Approximate 20% usage of students and faculty are documented after ILMS Implementation.

LCS IS installed in Medical, Dental, Nursing, Physiotherapy, Pharmacy Lecture halls. Automatic recording is done as per Timetable schedule by LCS. LCS portal is connected and

registered teachers and staff can use the portal for Lectures with Graphical inter phase of Data. It provides students the deeper understanding of their topics as they review classroom content at any time, from anywhere. Web Application include automated lecture capture, remote access, live streaming, attachments, notes, video editing, bookmarks, search, playlist, and so on. The performance of the Teachers is monitored by this system.

6.3.5 - Institution has Performance Appraisal System for teaching and non-teaching staff

The performance appraisal system is a regular review of employee's job performance, the quantity and quality of work performance and the overall contribution to the institute. It gives an opportunity to recognize and reward the employee in terms of increments and promotions.

The performance appraisal is done for total 500 marks and faculty attaining 50% marks are considered eligible for continuation. The prescribed self-appraisal form for the teaching faculty as per the UGC regulated guidelines are considered for easy assessment of faculty performance.

The self-appraisal form is submitted to Dean of the faculty, after the recommendation of his/her head of the department and based upon the performance indicators (API Score). The self-appraisal form is linked with appreciation, rewards, recognitions and incentives for research facilities. This self-appraisal form is helpful for considering promotion under career advancement scheme.

The self-appraisal form is also used for assigning the administrative responsibilities to deserving faculties, monitoring and review of recruitment policies and streamlining the teaching learning strategies. It is also used for deciding awarding mild penalties.

The self-appraisal assessment system is implemented in each cadre and is helpful in appraising the strength of the employee and to improve the performance of the employees.

Optimum Utilization of Resources;

The internal & external audits along with the finance Committee and the Board of Management effectively monitor the Utilization of the finances. As per perspective plan, on recommendation of Finance Committee and IQAC, budget is approved by Board of Management.

The University follows a functional SOP and a purchase Policy. A Building Works Committee is in place as per the by-law. The University has installation of 975 KVA rooftop solar grids on monthly payment of Rs. 4.46 per generated units.

The University utilizes its resources to the optimum and for Institutional developments.

7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

Different types of waste are collected, segregated and disposed off as per the guidelines of Maharashtra Pollution Control Board (MPCB) at KIMSDU.

Biomedical waste from the hospital is sent to 'Karad Hospital Association' which is a MPCB's authorized common biomedical waste treatment, storage & disposal facility. Biomedical waste collection is done twice daily as per the agreement.

Non-hazardous waste is separated and dry waste is handed over to municipal agency, organic waste is sent to organic waste management plant to generate 100% organic manure. Approximately 70 Kg of compost is generated from 220 kg of food waste daily.

E-Waste is collected in separate well marked bins and handed over to M/s Eco Recycling Ltd. - an authorized recycler for processing.

Sewage treatment plant (STP): -

Two STP's are installed within campus with 500KLD capacity of each. Liquid waste of approximately 350KLD gets treated in the plant. Among 350KLD, approximately 320KLD of treated water is generated from the STP. Daily, 300KLD of treated water is used for gardening.

Effluent treatment plant: -

Plant of 100KLD capacity treats approximately 45KLD of waste water generated in labs and laundry.

Radioactive chemicals and Incinerator ash:-

Digital imaging services completely eliminate radioactive waste generation.
