FEEDBACK ANALYSIS – PROCESS

BACKGROUND

Krishna Vishwa Vidyapeeth "Deemed to be University," Karad (KVV), previously known as Krishna Institute of Medical Sciences "Deemed to Be" University, Karad (KIMSDU), offers a curriculum tailored to student needs, providing a comprehensive learning experience that aligns with the institution's vision and mission of academic excellence, spiritual vitality, and social relevance. The university emphasizes fostering entrepreneurial skills and encouraging innovation from an educator's standpoint.

KVV has established a well-defined process for designing, developing, and revising its curriculum continuously to meet the required program and course outcomes, adhering strictly to the standards set by regulatory bodies. The university is equipped with state-of-the-art infrastructure and sufficient physical facilities to support curriculum implementation, teaching, learning, and skill acquisition, as per the guidelines of relevant authorities.

As a result of these efforts, KVV has received numerous accolades and accreditations, reflecting the success of its stakeholders. A key aspect of achieving this excellence is the use of feedback from various stakeholders to enhance and update the quality of education provided. Consequently, KVV has implemented a mechanism for collecting feedback from stakeholders, in accordance with the requirements of the National Assessment and Accreditation Council (NAAC):

1. Students
2. Teachers
3. Alumni
4. Professionals
5. Employers

QUESTIONNAIRE

Questionnaires for taking feedback from the above stakeholders were developed as per KVV's Standard Operating Procedure (SOP) for Feedback.

RESPONSE COLLECTION

For the Academic Year 2023-24, we continued using our in-house platform for collecting feedback, following positive responses from nodal officers and stakeholders regarding the new feedback system introduced in 2021-22. This system has been granted copyright by the Copyright Office, Government of India (Reg No L-126130/2023, dated 15/06/2023).

This feedback system offers the following benefits:

1. User-friendly:
 - a. The minimalist design ensures fast website loading.
 - b. A single common link for each stakeholder simplifies sharing through various communication channels and facilitates response collection.
2. Data integrity:
 - a. Basic background data is auto-loaded based on the PRN entered by students.
 - b. 'One Time Password' (OTP) verification for both mobile numbers and email IDs prevents data corruption and duplication.

3. Anonymity:
 - a. Random codes are generated in the database for each stakeholder response, and access to the complete database is restricted according to ‘Standard Operating Procedure’ (SOP) guidelines.
4. Ease of understanding:
 - a. The questions cover a wide range of curricular, co-curricular, and extra-curricular activities. Terminology explanations, with additional reference links, ensure stakeholders have a better understanding and perspective of university activities.

The links were open for responses from 01 July 2024 to 15 July 2024. As per SOP guidelines, response collection was centralized, with only two officers having access to the data.

Additionally, feedback on the in-house platform and suggestions for improvement were gathered through an ANONYMOUS and OPTIONAL "Feedback on Feedback" link. The responses will be analyzed and used to enhance the in-house feedback system in the future.

ANALYSIS

The results were analyzed using descriptive statistics and presented graphically as 'percentages' and the numerical 'most frequent response.' Responses to open-ended questions were categorized under 'Remarks' and 'Suggestions.' The data was anonymized and then shared with the respective faculty for further processing.

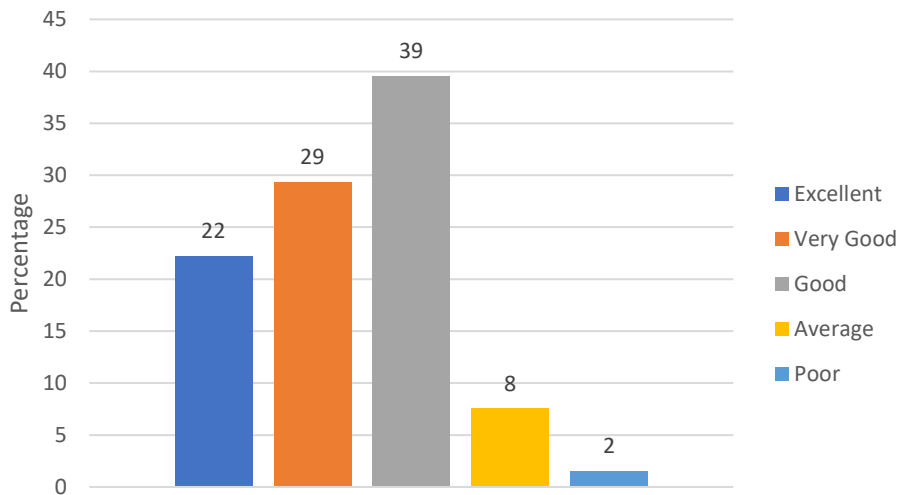
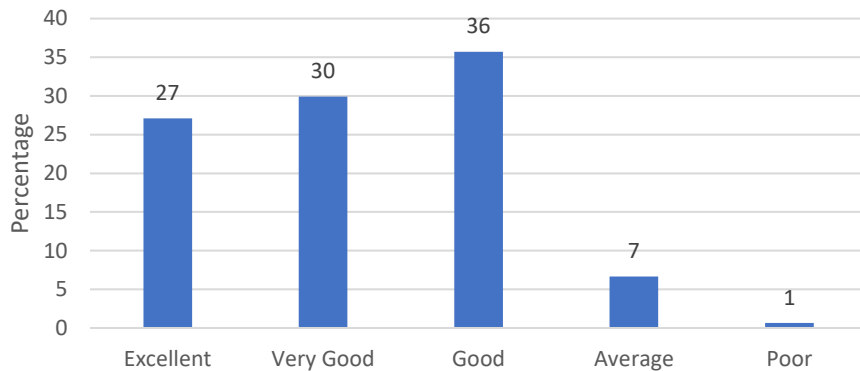
INTERPRETATION

A combined rating of over 75% for ‘Excellent,’ ‘Very Good,’ and ‘Good’ on any given question was considered a favorable response. Similarly, a most frequent response score of 3 or higher for each question was deemed favorable. No further action was required for these favorable responses.

Open-ended question responses were reviewed for positive feedback, which was categorized as ‘Remarks’ in the analysis, while suggestions for improvement were categorized as ‘Suggestions.’ Suggestions related to curricular aspects were forwarded to the respective faculty for necessary action.

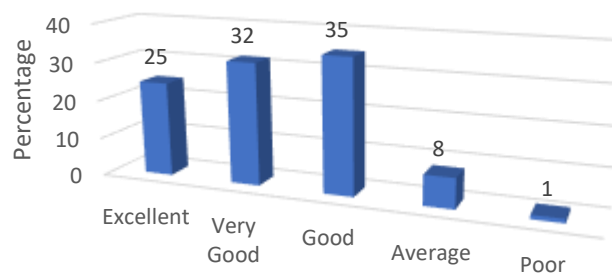

Please introduce more of case-based studies in subjects that are needed for USMLE and other international examinations. These need to be introduced into final year as well as 1;2nd and 3rd year

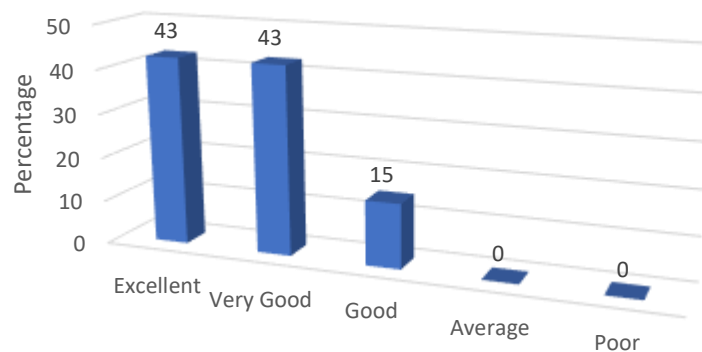
