➤ Essential Qualification and Experience

A person possessing the highest level of competence, integrity, morals and institutional commitment is to be appointed as the Vice-Chancellor. The person to be appointed as the Vice-Chancellor should be a distinguished academician, with a minimum of ten years of experience as a Professor in a University or ten years of experience in a reputed research and / or academic administrative organization with proof of having demonstrated academic leadership.

Additionally, the candidate applying for the post of Vice Chancellor should

1. Be able to provide leadership by his/her own example;
2. Be able to provide vision; and have ability to translate the same into reality in the interest of students and society;

➤ Desirable Qualifications and Experience

1. Post graduate degree in Medical / Allied Health Sciences or doctorate in any other faculty with good academic record.
2. Minimum of 5 research publications in peer-reviewed / referred indexed National / International scientific journals after the requisite qualification and/or published quality books / book chapters in a recognized discipline, referenced for study in higher education at the national / international level. Have an excellent record of patent filed/granted/valorized.
3. At least 5 years of Administrative Experience in the field of higher education not below the rank of Professor and Head of the Department in a university/ Principal (in Professor's grade) of a Senior College/ Head of a National / International Institution of Advanced learning.
4. Experience of execution of Major Research Projects.
5. Experience of working with International Bodies or International exposure through participation in workshops, seminars, or conferences held outside the country.
6. Membership/ election to fellowship of Prestigious National / International Professional Bodies/ Academies.
7. Should be a recipient of Prestigious Awards / Honours / Recognitions.
8. Experience in organizing events such as workshops, seminars, and conferences at the

➤ Tenure and Service Conditions

The person appointed as the Vice Chancellor shall, subject to the terms and conditions of the contract of service, hold office for a period of 05 (five) years from the date on which he/she takes charge of his/her office or till he/she attains the age of 70 (seventy) years, whichever is earlier and he/she shall be eligible for re-appointment for one more term by following the procedure for the appointment of Vice Chancellor.

The Service Conditions for the post shall be governed by the provisions of the Krishna Vishwa Vidyapeeth (Deemed to be University) MoA/ Rules as per the University Grant Commission (Institutions Deemed to Universities) Regulations 2023/ extant applicable Government of Maharashtra Guidelines/Rules/Orders.
