E. GENERAL

- Bidder shall submit the following documents as proof for PQ Criteria:

- a. Copy of qualifying work order for such work with work order number and date indicating scope of work and value completed with all relevant technical and other details.
- b. Completion certificate from the client certifying completed value, satisfactory completion, commissioning, and successful guarantee tests towards the work order of such project submitted above as proof.
